Fr. Wildes called the meeting to order at 10:40 a.m.

Dean Brown moved to approve the minutes of the March 23, 2007 meeting. Dr. Favre seconded – motion passed.

Fr. Wildes circulated the Request for Position, Inspector General for the City of New Orleans that was sent to the Civil Service Commission. The Commission approved the position.

Presently the ERB is waiting for a letter of indemnification from the city.

Mrs. Nalty reviewed some minor adjustments to the By-Laws. These technical adjustments will be made, By-Laws to be circulated and a vote taken at the April 24th meeting.

Professor Lorio will present some procedures for public comment at the next meeting.

Professor Marcello presented suggested legislation to the committee for discussion concerning open meetings and public records. This legislation would exempt the ERB from public disclosure and allow for Executive Session in investigative proceedings regarding allegations of misconduct.

Rev. Tilton recommended that the ERB move forward with legislation on open meetings and pubic records. Professor Lorio seconded – motion passed.

Fr. Wildes reported inquires have been made concerning the Office of Inspector General and some applications received for consideration. Discussion was held regarding hiring procedures.

The list of requirements will be referred to and candidates not meeting requirements will be eliminated.

Reference checks will be conducted by staff or board assignment on eligible candidates.

Committee requested information on best practices. Fr. Wildes will contact professional associations requesting information.

A conference call was requested at the next meeting with cities having Office of Inspector Generals in place. A list of appropriate questions will be available for this call.

A site visit was recommended should such be necessary.

Future meeting dates were discussed. The committee decided on the fourth Tuesday of each month at 10:30 a.m., effective in May. The location will continue to be Xavier University.
