



## **Ethics Review Board for the City of New Orleans**

**Board Meeting of July 27, 2020 at 3:30 P.M.**

**Conducted via Zoom Teleconference Due to COVID-19 Emergency**

### **Minutes**

1. *Call to Order.*
  - 1.1. Board members present:

  - 1.3. Staff member present: Dane S. Ciolino, Executive Administrator and General Counsel.
  - 1.4. A 3:30 p.m., the Chair declared that a quorum of the board was present and commenced the meeting via Zoom videoconference and teleconference.
  - 1.5. The agenda for the meeting is attached.
2. *Ratification of Prior Written Certification of Emergency Need for Video Conference Meeting.* Pursuant to [State of Louisiana Executive Department Proclamation No. JBE 2020-30 Section 4 \(March 16, 2020\)](#) and subsequent orders and legislation addressing the

COVID-19 state of emergency, the ERB unanimously agreed to conduct this meeting by video conference and audio conference after certifying that the ERB would not otherwise have been able to operate due to quorum requirements due to the ongoing COVID-19 emergency.

3. *Approval of the Minutes.*

- 3.1. Mr. Ricks suggested a correction to the minutes to note that in Section 5.6 he suggested the need for “definitive standards and best practices” to guide the work of the Quality Assurance Committees.
- 3.2. The Board unanimously approved the minutes as corrected for the June 29, 2020 board meeting.

4. *Discussion of Monthly Report of the Office of Inspector General.*

- 4.1. The Office of the Inspector General was represented by IG Derry Harper and Larry Douglass. Other staff members were in attendance as well.
- 4.2. The OIG filed its monthly report late. Mr. Harper attributed it to “Cox problems.”
- 4.3. Mr. Douglass and Mr. Harper discussed the report (attached).
- 4.4. Among other investigations, the OIG discussed the report regarding the S&WB. Mr. Cowan asked whether there was any time period within which the S&WB should comply with the suggestions made in the report. Mr. Douglass responded, “six months.”
- 4.5. Ms. Brooks inquired into how any follow up would be conducted. Mr. Douglass discussed how documents would be gathered and other matters monitored.

5. *Discussion of Monthly Report of the Office of the Independent Police Monitor.*

- 5.1. IPM Susan Hutson appeared for the OIPM.
- 5.2. Ms. Hutson read from and emphasized various portions of the monthly report of the OIPM (attached).
- 5.3. Ms. Hutson noted that her office has received a record number of complaints, due in part because of the NOPD use of tear gas at a protest. She also noted that there have been recent officer-involved shootings.
- 5.4. Mr. Brown congratulated Ms. Hutson for being president of NACOLE.
- 5.5. Ms. Calderon probed Ms. Hutson on what real reforms were happening in the NOPD. Ms. Hutson noted that officers involved in shootings have been drug tested. She also noted that her office is obtaining more community input. She also reported that the City Council is supporting her efforts.

- 5.6. Mr. Ricks probed as to whether mediations have increased as a result of the recent protests and civil unrest. Ms. Hutson reported that the NOPD has increased the issuance of summonses rather than arrests as a result of the protests.
  - 5.7. Dr. Cowan asked how the NOPD has performed in the recent civil protests. Ms. Hutson reported that the NOPD performed well, knelt with protestors, but, unfortunately used tear gas. That conduct was a “big setback,” and “changed the narrative.”
  - 5.8. Dr. Cowan asked about the status of the OIPM peer review. Ms. Hutson noted that it was underway, but that there has been some turnover in the composition of the committee. Dr. Cowan emphasized that it was important to have an independent peer review even with Ms. Hutson’s position as president of NACOLE.
6. *Report of the Ethics Trainer.*
- 6.1. Ms. Hackett and Mr. Caulfield attended the board meeting.
  - 6.2. Ms. Hackett filed no monthly report.
  - 6.3. Ms. Hackett noted that there have been no in-person training sessions. She noted that her training is designed to be in-person and that it has made her job difficult to do trainings otherwise.
  - 6.4. Mr. Ricks asked Ms. Hackett to re-engage the state board on on-line ethics training.
  - 6.5. Ms. Calderon noted that Ms. Hackett should work toward getting trainings on-line. It is “important to adapt,” she emphasized.
  - 6.6. Dr. Cowan agreed and queried why on-line training is perceived to be less effective. Mr. Caulfield noted that candor in the room is critically important. Dr. Cowan suggested that rule changes would be appropriate at the state board level to permit more on-line training.
7. *Report of Executive Administrator and General Counsel.*
- 7.1. Mr. Ciolino reported that no news complaints had been received.
  - 7.2. Mr. Ciolino noted that there were several complaints and other issues to deal with at the executive session.
  - 7.3. Mr. Ciolino discussed the Board’s upcoming deadlines and events.

8. *Executive Session.*

- 8.1. The ERB went into executive session after a motion by Mr. Brown and second to do so by another board member. The ERB went into executive session after a unanimous “affirmative” vote of the board.
- 8.2. After the executive session, the board unanimously voted to go back into public session at 7:04 p.m.
- 8.3. The board unanimously voted to dismiss two complaints, namely, 2020-01 and 2020-03 after board members made the appropriate motions and seconds.
- 8.4. The board unanimously voted to defer matter 2020-02 at the request of the complainant after an appropriate motion and second.

9. *Adjournment.*

- 9.1. A motion was made to adjourn the board meeting. The motion was seconded.
- 9.2. The Board unanimously voted to adjourn.
- 9.3. The meeting was adjourned at 7:07 p.m.

# **Monthly Report of OIPM**

# Community Letter

Dear New Orleans Community,

In the month of May, New Orleans and the country started calling for police reform and changes in the way the police engage in the community. The Office of the Independent Police Monitor not only monitored the community protests occurring in New Orleans but engaged with the community to learn more about what meaningful changes they were seeking from their police department. The protests and calls for change in May have turned into real reform in June – both locally and nationally. The Office of the Independent Police Monitor continues to spearhead this work by presenting to and working with City Council on resolutions and ordinances, amplifying the voices of the community, and providing the oversight and accountability necessary to grow a better police department for the city.

The Office of the Independent Police Monitor received a record number of complaints this month from the community – submitting twenty-six (26) complaint referrals to the Public Integrity Bureau. The majority of the complaints we received focused on how the NOPD used tear gas and rubber projectiles to respond to community led protests on June 3, 2020 on the Crescent City Bridge. Though OIPM supports and appreciates the NOPD's attempts at transparency and public education to explain that tactical decision, the OIPM has expressed concerns regarding the apparent lack of policy around those tactics, the initial misinformation released about the tactics used that night, and the affect that decision had on public trust in the NOPD. In response to those concerns, the OIPM wrote a public letter to Chief Ferguson highlighting key points shared in the complaints and stating our intent to collaborate with the NOPD to develop necessary policy and improve training and practice to ensure such tactics are not utilized by the police again. The OIPM also started drafting policy and training recommendations regarding policing during protests and hopes to showcase this work this summer through resources for the community and formal recommendations to the NOPD.

Since June 3, 2020, the OIPM's Use of Force Department has spoken with protesters affected by the tear gas, received footage and photographs, and monitored the NOPD's investigation into the use of force that night, including monitoring statements taken from those injured. The OIPM will continue to provide such oversight to all investigations regarding June 3, 2020 until they are complete.

During the month of June, the OIPM continued our work in discipline monitoring by attending forty-four (44) predisposition conferences and disciplinary hearings. The OIPM provided feedback to the NOPD regarding strip searches, retaliation, secondary employment, and a NOPD officer turning work interactions into personal relationships that originated with calls to service and will work with leadership to develop new policy.

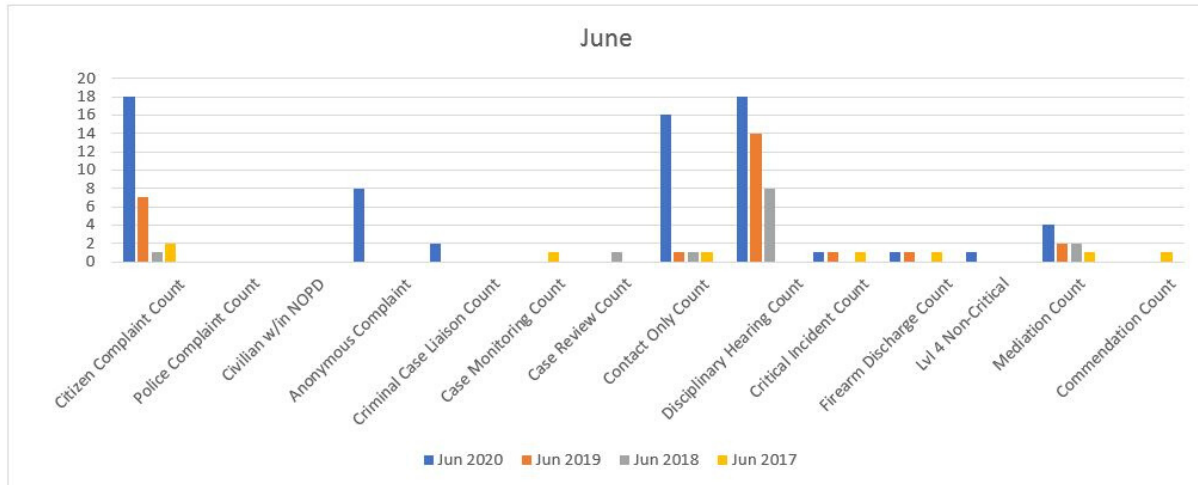
In June, OIPM responded to the fifth (5th) officer involved shooting of the year. The OIPM stayed on site monitoring the investigation and will continue to monitor this investigation along with all the other Force Investigation Team investigations being conducted.

This month the city started taking some real steps to change policing and the OIPM will continue to work with elected officials, the NOPD leadership, and our community to ensure the needs of the community are heard, understood, and realized.

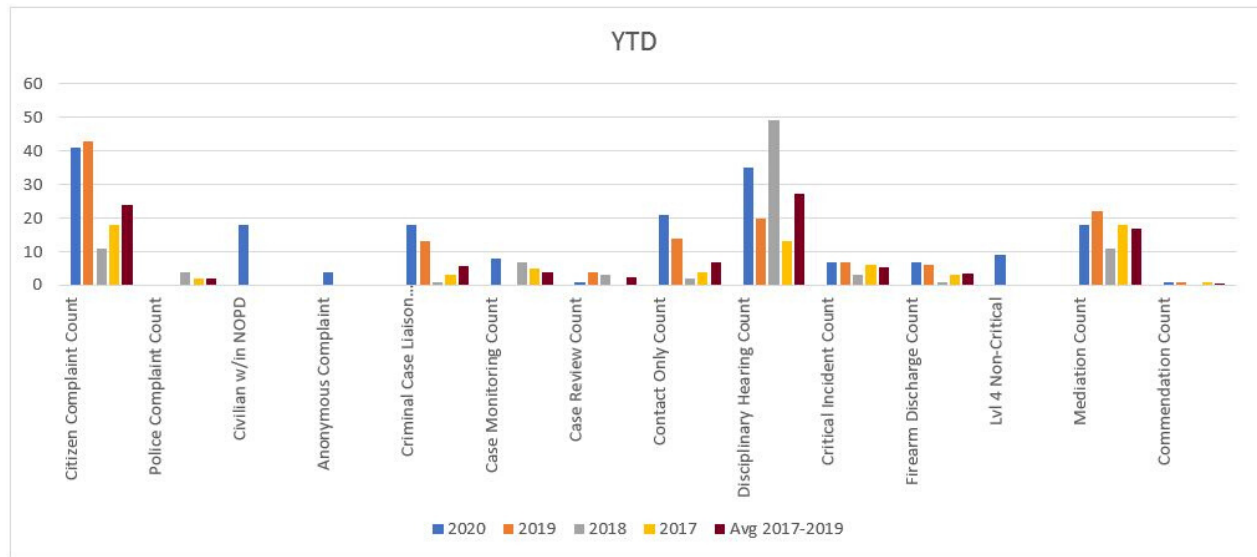

AC2020-0039	The Complainant stated that NOPD Officers fired tear gas canisters and potentially rubber bullets into a crowd of unarmed civilians, proceeding to beat protesters with batons while they were blinded. In addition, the complainant stated he saw protesters collapsed and bleeding.
AC2020-0040	Complainant states that NOPD said they could pass the police blockade on the Crescent City Connection Bridge then tear gassed the crowd and shot them with potentially rubber bullets as they passed.
AC2020-0041	Complainant stated that the NOPD used tear gas on peaceful protesters without warning or provocation.
AC2020-0042	The Complainant stated that an NOPD officer did not wear a mask in a federal building when everyone else around him was wearing one.
AC2020-0048	Complainant stated that the NOPD used tear gas against a crowd of peaceful protesters.
AC2020-0052	Complainant stated they witnessed NOPD officers illegally detain and take away two peaceful protesters out of their cars and forcibly place them in police vehicles.
AC2020-0056	Complainant was a protester on the Crescent City Connection Bridge on June 3rd and shared her account of the NOPD utilizing tear gas on protesters.
AC2020-0057	Complainant alleges that NOPD officers used unnecessary force to arrest a man and lied about what happened in the police report to increase charges against the man. The complainant provided a video link to corroborate their allegations.

Critical Incident	
CI2020-0007	During a community led protest on June 3, 2020, a crowd of several hundred individuals proceeded on foot toward the Westbank. NOPD officers formed a line to prevent the crowd from entering traffic on the main lanes of travel of the Crescent City Connection Bridge. There was dialogue between the officers and the protesters. NOPD officers deployed CS gas in at least two forms, one by hand and the other via a launching device. NOPD officers also fired rubber projectiles into the crowd. One individual was struck in the head and required medical treatment.
CI2020-0008	NOPD 4th District officers responded to calls of shots fired at Jackson's Landing Apartments. While conducting an investigation, the individual began firing his weapon at NOPD officers. A vehicle pursuit ensued and gunfire was exchanged between the individual and NOPD. The pursuit ended at Westbank Expressway & Central Avenue in Westwego, LA. The perpetrator crashed, fled on foot, and was apprehended by JPSO after the JPSO vehicle allegedly struck the individual.

# Complaints and Discipline

The OIPM serves as an alternative site for civilians and police officers alike to file complaints of misconduct against the NOPD. These complaints and allegations are compiled into referrals by the OIPM and provided to the Public Integrity Bureau (PIB) for them to investigate. The OIPM monitors and reviews the classification and investigation conducted by PIB. If the complaint continues into a disciplinary proceeding, the OIPM will continue to monitor and review the disciplinary process. OIPM monitors and reviews disciplinary proceedings conducted by NOPD to ensure accountability and fairness. The OIPM reviews the disciplinary investigation and attends the subsequent disciplinary hearings where the OIPM will provide systemic and individualized findings and recommendations based on NOPD's investigation. The OIPM conducts a thorough review of the proceedings, findings, and recommendations that is available for review by both the NOPD and the New Orleans community.

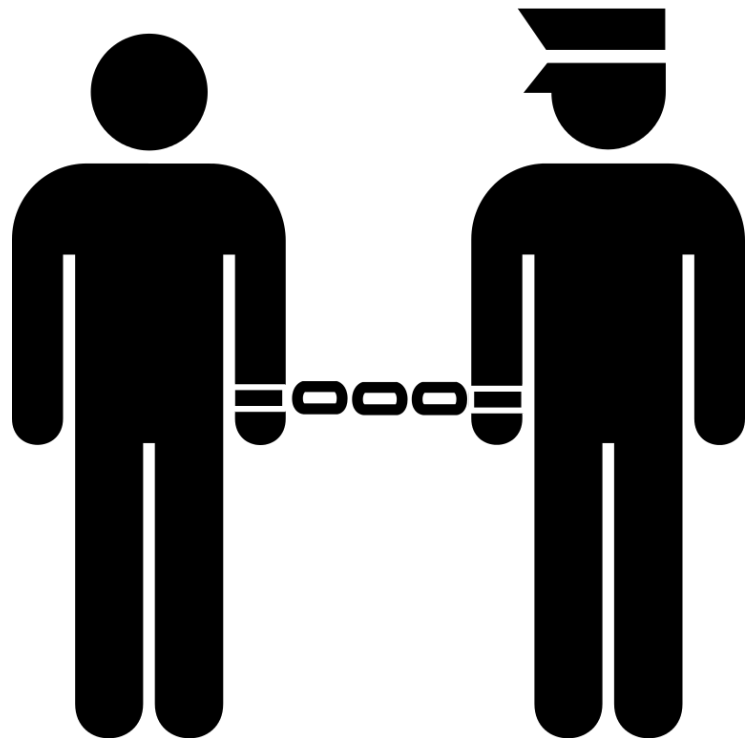

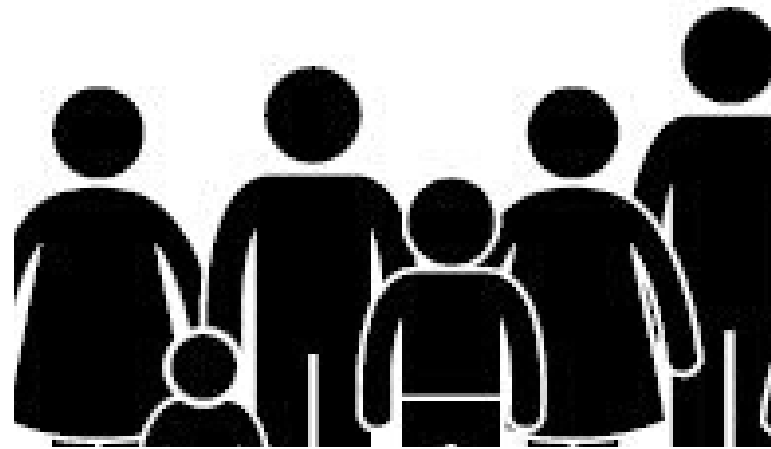


# Community Relations
